- # 1: Contribute to MacEwan University Strategic Vision 2030 and to the School of Business Mission
 - The core of the strategic vision of the university is on redoubling our emphasis on exceptional undergraduate teaching.
 - The mission of the school of business is: Through teaching greatness and scholarship, we develop culturally aware business professionals, contribute to our disciplines, and enable organizations to thrive.
 - The BCom core courses contribute to achieving MacEwan University strategic vision 2030 and School of Business mission.
- # 2: BCom Program Structure
 - BCom Core: The BCom core courses provide for 25-50% (10 to 20) of the courses required to complete the BCom degree. We need to be mindful of the business core content and non-business core content (or breadth of the core).
 - Primary Major: Up to 25% of the BCom program, depending on the major.
 - Electives: The remaining of the program is provided by open electives. The structure of the BCom program allow students the option of completing a second BCom major or approved out-of-faculty major; BCom minors and/or out-of-faculty minors; an honours option; or business and non-business courses of their choosing.

- Recognition of concerns about course section scheduling, such as classes being too full and not enough available.
- Intersection of student need and section availability is a bit of a shaded box, and affected by multiple factors, including: University Assets, Program Structure, Course Specifications, Human Capital, Consumer Requirements, and Purchasing Schedules.
- Continue to work at the problem, and in meantime focusing on information and communication with Chairs.

Student Academic Standing:

Two updates from the April 9th, 2024, council meeting:

1. Curricular Items – Programs of Study (PoS):

Summary:

The Departments of Anthropology, Economics, Political Science, and Psychology proposed new programs starting in Fall 2025 and 2026:

- Urban Wellness Minor (Anthropology, Economics, and Political Science) This minor will equip students with the skills to understand urban environmental, social, and economic issues. It encourages exploring urban challenges and policy solutions through a multi- and interdisciplinary approach that includes urban wellness, political science, anthropology, and economics. The Urban Wellness Capstone lets students apply their knowledge in real urban settings and interact with various stakeholders.
- **Post-Baccalaureate Certificate in Behaviour Analysis (Psychology)** This 24-credit program, including six credits of hands-on learning, teaches foundational behavior analysis principles. It prepares students to apply methods that facilitate significant behavioral changes, useful in fields like autism, education, and clinical behavior, among others. Replacing the 15-credit Behavioural Interventions Certification, this expanded program includes additional courses and fieldwork necessary for BCaBA certification and admits students three times a year.

2. Dean Melike Schalomon's Update on the BSc Action Plan Implementation: During the 2023-24 academic year, the Faculty of Arts and Science has made progress on the BSc

Action Plan. To date, 42% of the tasks have been completed, and significant progress has been made on the rest, with an average completion rate of 70%.

- PLO's for Dept. of Public Safety and Justice Studies for ECRP, Correctional Services Program, and Police & Investigation. With the new degree, looking closer at diploma learning outcomes so they ladder meaningfully into the degree. Passed without issues.
- Program of Study changes to the same Dept. diploma programs: Correctional services, Emergency C&R, P&I. Passed without issues.
- Correctional Services program name change to Community Justice and Corrections. Captures more of what is included in the program. New name captures more what is covered. Passed without issues.
- There were various other changes to the Bachelor of Social Work degree and diploma, and the Bachelor of Early Childhood Curriculum Studies admission criteria. Passed without issues.
- Proposal of a minor in Childhood, Youth and Family Studies adjusting the requirements for those students in A&S who are taking this as a minor. Passed without issues
- Dr. Matthew LeGrone (Associate Dean) & CTL representative did a presentation on Artificial Intelligence - interesting presentation and discussion afterwards. Approved Master course syllabi for 4 courses for Sept 2024.

Approved Master course syllabi for 2 courses for July 2024.

Approved the Terms of Reference for the Teaching and Learning Excellence Committee. Also noted that there will be a general call for committee members.

Associate Dean Jill Vihos discussed the reasoning behind the Bridge to Canadian Nursing Program of Study Correction in consideration of the return of the one-credit courses from the School of Continuing Education.

Spotlight on Teaching

Presentation on the impact of climate change on health from three different class levels. *New Business*

The Dean discussed the 2024-2025 Performance Review Criteria. The meaning of service was discussed and how open to interpretation the definition in the collective agreement was. Another point covered was on scholarship. Again the Dean mentioned the wide array of possibilities but cautioned that those contributions needed to be unique. The example she gave was presenting to different audiences the exact same presentation each time was not unique.

Budget Presentation

To promote transparency within the School, the Dean had the upcoming School of Nursing budget presented. Then opened the floor to questions.

• School of Continuing Education | Reported by Dr. Hadi Chapardar, School of Business Dean's designate.

The School of Continuing Education (SEC) Council Meeting was held on April 15, 2024. This relatively short meeting (concluding in about 40 minutes) mainly aimed at the dissemination of regular updates and news. A few of the news, which might be of interest of colleagues at the SofB, include:

- Recent SEC budget highlights demonstrated an ongoing growth in the third quarter of 2023-24. Overall, the enrolment had grown over about 200 per cent above the planned level. It was suggested that more efficient visa processing had a significant impact on the enrollment level.
- The SCE aims to maintain its continual growth by diversification in two areas: first, the portfolio of programs, and second, the range of countries the SEC targets.
- The SCE is now presenting a new set of micro-credential courses on a regular basis along with other courses. The School continues its micro-credential development in collaboration with other Albertan institutions.

- 2.0 Reports
 - 2.1 President/Chair
 - 1. Bill 18 provincial priorities act
 - i. Federal program that will give money if the province will match, so the problem is who is in charge.
 - ii. PSI with respect to research funding.
 - iii. They want to advocate for CARVA which is modelled after Quebec.
 - iv. Stakeholder consultation this summer. Work on regulation.
 - 2. Paying attention to Protest across campuses.
 - i. We care about safety and security.
 - ii. We will use policies and procedures.
 - iii. So far, nothing has happened here.
 - 3. Celebration for the SOB building. Expecting 350 people.
 - 4. She visited Yukon U who would like to be part of Universities Canada. MacEwan went through the same exercise when it was a college university.
 - 2.2 Provost Monk
 - 5. Academic recruitment: May 1 44 tenure track starting July 1. And four offers outstanding. There have been some failed searches. The goal was our recruitment numbers of mid-50s. but hopefully, we will recruit 50. 35 sessional extended offers.

- 6. Promotion: 36 successful of 44 applications including seven full new professors. 80% success rate. Should focus on a whole career rather than the last 3 or 4 years. Often TMI about teaching notes. They need to argue how they have become an effective teacher. Other people rush to apply who would be better to wait to detail more substance
- 7. Sabbaticals:
- 8. 2024-25:
 - i. Student affairs want to evolve into two separate entities.
 - ii. Exam centre is overwhelmed with work. The status quo cannot remain. The Provost wants consistency for all students – those writing with the prof and those writing in the exam centre.
 - iii. Subcommittee on AI.
 - iv. Approve an academic schedule for 2025 26: expect to have some exams on Sunday but with limited use. Sept 30 now without schedule now makes us consider whether we may not have a Fall Reading Week. This may help avoid Sunday exams entirely. There is still an active grievance with the FA for general work on the weekends.
- 9. Modality definitions made two years ago will be reviewed re: definitions of face-to-face, hybrid courses, etc. Feedback from students is that there is too much online content in face-to-face courses.

 - Maureen Lomas: no concerns in the audit. \$10 M surplus in the year, which is 3% of the budget. UCC building. Revenues were \$20 M higher than budgeted. Higher contributions from continuing education. Interest generated investment income. Offset by reduction of sports and Wellenses fee. Increased payout of bursaries and scholarships. Buying new equipment. We are not allowed to run a deficit. They aim to protect academic hiring. But by Sept, if don't hire, then figure out where to use the money elsewhere. Some of the money is set aside to pay for deferred assets such as furnace and HVAC.
 - President: we have had surpluses before, but we lucked out with revenue this year.
