6.0 Leadership & Governance Updates

6.1 Dean's Update (Dean Perlow):

• **Mission:** Through teaching greatness and scholarship, we develop culturally aware business professionals, contribute to our disciplines, and enable organizations to thrive.

University Relations asked Dean Richard Perlow to present "take-a-ways" in a speech he will be giving to the MacEwan Means Business Campaign Cabinet members. The five key points he wants the Cabinet members to communicate to potential donors are:

- 1. The School of Business faculty embody teaching greatness
- 2. We provide unique opportunities for students to develop their potential
- 3. We develop skills students need for jobs now and in the future
- 4. We enable Edmonton organizations to thrive
- 5. We aim to provide Edmonton with culturally aware business professionals who make a difference.

The Dean provided an overview of *Learning Goals and Objectives* that included the following:

- Outstanding Experience review
- AOL Process
- Example of an assessment Schedule
- Examples of learning goals
- Learning Objectives examples
- An example of a written communications rubric

Dean Perlow also discussed:

- People going up for full professor should review the process for selecting external reviewers.
- Myers Norris Penny is looking for faculty to come in to talk about career opportunities and do workshops.
- Enrollments: We need to increase our enrolments. Tactics can include engaging with high school students before they enter Grade 12, bring students to campus as we had done with one high school this year, increase our international enrolments. Ali and Sherif joined MacEwan International on

recruiting trips. They tell me it takes a while to develop relationships with international schools and agents

- Alumni and Allard Chair Engagement: In the upcoming academic year, the dean wants to have a Wine and Cheese event to invite School of Business alums. At the networking event we would have a former Allard Chair speak to the attendees about a business topic. The dean will speak for about 5-10 minutes about happenings at the business school. The School of Business has many great alums, and this would be an opportunity to have them network with each other.
- **Executive in Residence (EIR)**: The new EIR, Tristan Ham, arrives in August to meet and run the MacEwan Venture Lab. Students and people from the community can participate. The EIR initiative is an Edmonton Regional Innovation Network initiative for Edmonton PSIs that Alberta Innovates funds and Edmonton Unlimited overseas. It is aimed at fostering student entrepreneurial activities..

During the discussion, the following questions arose:

- Q. Are we going to have another student conference?
 - A. Yes, on October 13, 2023. The Associate Dean, Ali Taleb, will provide details.

6.2 Associate Deans' Update: Associate Dean Sherif Elbarrad (away - no update)

Associate Dean Ali Taleb provided the following update:

- Study Tours: There are currently no study tours this year: By the end of summer, will determine dates/destinations and options for tours in September 2023. Europe is a popular destination; have also provided tours in Africa and Latin America (e.g. Brazil; Mexico). Contact the Associate Dean, if interested in study tours, e.g. Latin America or Eastern Europe, etc.
- The Associate. Dean did an online presentation to students in Jakarta, Indonesia, on Friday, June 23, 2023. Received good feedback from students.
- **Technology Alberta**: provides services for technology for lunch presentations. Will send an email in the Fall for those interested in presenting for an hour.
- Université Lavalle, in Quebec City: is sending students for missions for Quebec companies. International students will provide consulting work for service providers for Canadian companies and as International partners leverages. The Associate Dean has been approached for partnership in Alberta. MacEwan University's School of Business will be sending 5-6 students to help with the market research and entrepreneurship; this will help renew students' international experience.
- Student Business Conference: will be held on October 13, 2023, in the Convention Centre. Hoping to have 300-500 students. Have previously had 700 students at the student conference because of promotions in classes/course outlines (e.g. miss a class to attend the conference) encouraging students to attend. Seeking ideas for workshops (already received help with Major in Finance), including sessions.
- Updates within MacEwan University: would like to hear from you if you have had something published, e.g. book chapters, went to conference, etc., to include within updates.

During the discussion, the following questions/comments arose:

- Comment [from faculty]: Sometimes professors will give a small assignment (e.g. assignment worth 5-10 percent, to do a write up about the student conference).
- Q. Is the conference free?
 - A. It's about \$15.
- Comment [from faculty]: A couple of suggestions: 1. For the study abroad event in Fall, it would be helpful to talk about our Majors/Minors and nice to have a one-day showcase for

current students for our School of Business Majors/Minors. The demand/suggestion came from our students; 2. Workshops for faculty (Q&A – half hour workshop): we also need events for ourselves.
