5.3.4 Bachelor of Commerce Core Process

Fernando Angulo-Ruiz discussed the Bachelor of Commerce Core Process:
The **BCom Core Process** was **approved** by BPCC on April 17th, 2023.

- *Policies (This procedure is part of the Curriculum policy at MacEwan University):*
 - PROGRAM AND COURSE APPROVALS PROCEDURE (PCAP)
“Program(s): An organized schedule or selection of courses, typically with admission requirements, regulations, and learning outcomes, presented in the Academic Calendar, and leading to a credential and/or notation on a transcript.”
 - Provides key pointers for the process BPCC is following to recommend the BCom Core (sections 3.1, 3.2, 3.5 and 3.6 of PCAP)
 - A key main point: **CONSULTATION** in sections 3.2 and 3.6
- 3.2 (in PCAP) Consultation:
 - Faculty and staff are expected to cultivate and maintain formal networks with students, industry, and external peers and to consult regularly with those networks on curriculum, as appropriate.
- 3.6 (in PCAP) ... Institutional Consultation:
 - The Provost & Vice-President, Academic (or delegate) is responsible for facilitating an institutional consultation process, laid out in the Quality Assurance Handbook, through which notice of all credit Program and course proposals and changes, including those of §3.4 and §3.5, are posted for a minimum of two weeks. Non-credit Programs and courses are exempt from this process.
 - 3.6.1 Institutional consultation ensures that representatives of the Faculties/Schools and academic support units are notified of prospective changes and have an opportunity to consult, raise concerns, and address matters that impact them.
 - 3.6.2 Any participant in the consultation process can challenge or dispute a proposal that impacts them and, if such challenge or dispute is not resolved between the parties, the matter will be adjudicated by the GFC Committee or Council with the mandate deemed most germane to the dispute by the Provost & Vice-President, Academic (or delegate). The Provost & Vice-President, Academic (or delegate) may also dismiss a challenge at their discretion if it is deemed frivolous, that is, there is no broader impact.
 - 3.6.3 **Institutional consultation must take place before an item governed by §3.4 proceeds to the relevant GFC Committee or an item governed by §3.5 is approved by the relevant Faculty/School Council(s).**
- BPCC Agreed on BCom Core Approval process.
 1. BPCC agrees on a BCom core recommendation (without formally approving it)
 2. We bring our tentative recommendations to consultation as per section 3.2 of PCAP
 3. BPCC updates recommendations based on feedback (if necessary)
 4. BPCC formally approves recommendations and send them to SoB council
 5. Before formal approval by SoB council, SoB engages in 3.6 (institutional consultation)
- Where are we now? We are still in Stage 1. BPCC agrees on a BCom recommendation (without formally approving it).
 - As part of Stage 1:
 - On April 3, 2023 BPCC received the recommendations from the BCom Core Sub-Committee. The sub-committee presented their analysis and

- recommendations with Q&A from BPCC members from 3:30 to close to 5:00 pm
 - On May 1, 2023 BPCC met for 5 hours, and we started conversations on the tentative agreement of the BCom core ...
 - No tentative agreement yet
 - 22 courses in the BCom Core. At most 19 courses in the BCom Core -- “Flexibility.” Created a tension – What is essential in the BCom core?
 - Consultation in Stage 2:
 - Internal to the University:
 - School of Business Council
 - Faculties outside the School of Business
 - Other bodies as part of PCAP 3.2 section and to be decided by BPCC
 - External to the University:
 - Bodies as part of PCAP 3.2 section and to be decided by BPCC
 - Sections 3.1 and 3.5 of PCAP
 - 3.1: Faculty and staff should consult the Quality Assurance Handbook for detailed guidance and information on relevant regulations, policies, procedures, and standards related to Program or course approvals.
 - 3.5: Any Program or course changes not covered in §3.4 above are approved by the relevant Faculty/School Council(s) in accordance with their approved procedures.
 - After Step 1
 - Internal
 - English Department
 - Anthropology, Economics, and Political Science Department
 - Students (e.g., clubs, SAMU, invitation to open forums)
 - External
 - BCom self study external peer reviewers' recommendations
 - EFMD report
 - Industry (e.g., Current and previous Allard Chairs, Professional Associations)
 - Consultation in 3.6
 - Broad Institutional Consultation
 - Via the Provost Office
 - Minimum 2 weeks.

6.0 Leadership & Governance Updates

6.1 Dean's Update (Dean Perlow):

University Relations asked Dean Richard Perlow to present “take-a-ways” in a speech he will be giving to the MacEwan Means Business Campaign Cabinet members. The five key points he wants the Cabinet members to communicate to potential donors are:

1. The School of Business faculty embody teaching greatness
2. We provide unique opportunities for students to develop their potential
3. We develop skills students need for jobs now and in the future
4. We enable Edmonton organizations to thrive
5. We aim to provide Edmonton with culturally aware business professionals who make a difference.

The Dean said that University Relations wants to hear specific student stories under each category and asked the faculty to submit them to Laura.

- We hired a sessional extended. Sessional extended faculty are eligible to apply for a non-course position if such a position is available. The collective agreement outlines the process for hiring sessional extendeds and nine-course tenure track faculty.
