## Gather your required documents:

Please note:

- Documents should be issued within 30 days of submitting your application
- If you are required to provide several documents in one section, you must scan all of them as one PDF document (the size limit is 4 MB)
- Your documents must be in English or French, if not, provide the English or French translation with an affidavit from the translator certifying the document

## Documents that are required for all students:

- Study Permit extension letter and Verification of Enrolment (request from [international@macewan.ca](mailto:international@macewan.ca), **allow 5 business days for processing**); PD certificate students must contact [sceinternational@macewan.ca](mailto:sceinternational@macewan.ca)
- Proof of means of financial support (an official bank statement, a letter from your parents stating that they will financially support you, etc.)
- Passport (a copy of the page with your name, date of birth, passport number, expiry date and a copy of every page that has stamps, visas, markings or signatures from Canada or other countries)

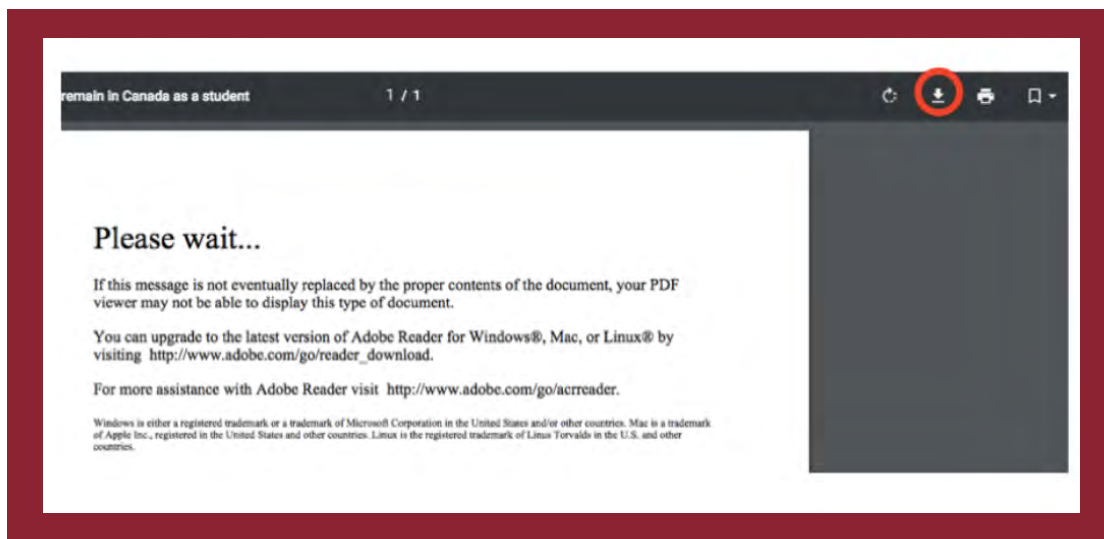
**STEP****FIVE**

Download an application form and save it as a PDF file in the folder on your computer.

Make sure you have [AdobeReader](#) installed on your computer. Click on the “Application to Change Conditions, Extend my Stay or remain in Canada as a Student (IMM5709) form. You will see a note “Opens a new window” and a small watch/cursor will appear. Please wait, the form is being downloaded. If you receive a message “Please wait” when you are downloading a form:

- Click on the download arrow at the top right to save the file onto your computer
- If you do not see the arrow, move your cursor to the top of the screen and it will appear
- Go to the folder where you saved this form and right click the mouse to open it with Adobe Reader

Validate your application form IMM5709 and upload it.

**SEVEN****STEP**

Upload your application documents.

**EIGHT**

Make sure you merge all the pages of each required document into one PDF document and upload it.

**STEP**

Pay the applicable fees and submit your application.

**NINE**

Once you submit your application you will see a “Congratulations!” notice on the page. After that you will receive an “acknowledgement of receipt” email into your IRCC account.

**AFTER YOU APPLY**

If you apply for a study permit extension before the expiry date of your current study permit, you can continue to study in Canada under the original/current study permit conditions until IRCC makes a decision on your study permit extension application. Even if your current study permit expires before the decision is made on your study permit application, you can continue study and/or work under your current study permit conditions. This period is called “maintained status.” Remember: If you leave Canada during this time, you will lose this maintained status and after re-entering Canada, you cannot resume study or work until you have received your new study permit.
