7. Budget Update – Suzanne LeBlanc & Dr. Lisa Rochman

- The school's financial performance year-to-date has been quite strong, with projected surplus across several programs
- Preparing 3-year budget projections that are due in November
- Several projects are underway including CRM integration, curriculum updates, Open Entry/Exit, and dual application automation
- Ongoing grants Foundational Learning Assistance (FLA) program, Ukrainian Support program, and Micro-Credential
- Recent government announcements on reduced international study permits, increasing eligibility requirements for PGWP, and reduced FLA funding due to Labour Market Transfer Agreement (LMTA)

- Canada Job Grant is also no longer available due to LMTA changes.
- \$70M cut to AB LMTA that impacted 6-8 different ministries
